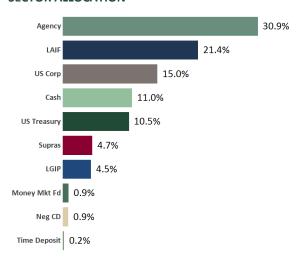

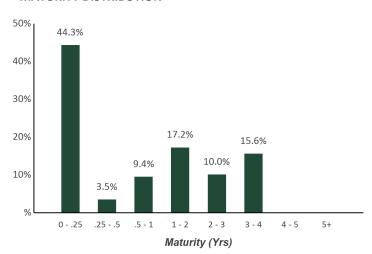

SECTOR ALLOCATION

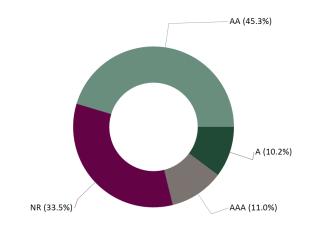
Average Life
