3 <u>COMMITTEE MATTERS</u>

3a) Approval of Minutes from the April 26, 2023, Regular Meeting.

o Member Daugherty had minor changes that were sent to the committee clerk.

Committee Action: Upon motion, by Member Daugherty seconded by Member Allman it is ORDERED that the minutes of the April 26, 2023, regular meeting be accepted.

o Motion passes with 8 approvals, 1 Abstain (Riley).

3b) June 2023 Measure B Financial Report

Presenter: Chair Miller

o Mary Alice Willeford, Deputy Director of BHRS Operations, presented the financial reports to the Measure B Committee. She mentioned the interest rates have doubled from what was budgeted for income estimated at \$200,000 and current amount at \$375,000 with it being projected to reach \$500,000.

Committee Action: None

3c) Update and Discussion Regarding Measure B Related Items at the Board of Supervisors Meetings.

Presenter: Chair Miller

o General services advised demolition of new psychiatric building on Whitmore Lane, expected to start early July.

Committee Action: None.

Public Comment: Supervisor Mulheren mentioned about Measure B and BHAB to create collaborative effort to inform the public of where the funds are being spent.

3d) Update and Discussion Regarding the Status of Current Measure B Projects

Presenter: Chair Miller

- o Training Center is still being rented out. Application can be found online.
- o Mobile Crisis Units are still responding to calls. There are concerns over not having safety equipment for staff responding to crisis calls.
- o January 2024 funding options to include having two crisis workers respond to each call.
- o \$9.3 million dollar grant was secured for the brick-and-mortar portion of the new psychiatric facility. The goal is to have the facility built by 2025.
- National Alliance on Mental Illness (NAMI) will not be renewing their contact.
 They will need to look at other options.
- Crisis respite center is up and running with approximately \$260,000 a year of Measure B funds used to bill to Medi-Cal.

Committee Action: None.

Public Comment: Supervisor John Haschak asked about crisis aftercare services. He looked over the financial report and mentioned seeing unspent funds. He was informed that unspent funds area was allotted for next fiscal year beginning July 1, 2023, in the amount of \$520,000.

3e) Request for Eight Additional Tables for the Behavioral Health Regional Training Center

Presenter: Tom Allman

• They need eight additional tables to provide more access for trainings but have no need for additional chairs.

Committee Action: Upon motion, by Member Allman, seconded by Member Daugherty it is ORDERED for the purchase of eight additional tables for the Behavioral Health Regional Training Center.

3f) Request Approval of Measure B Funds for Purpose of Consulting with County General Services Agency for Creation of the Long-Term Financial plan.

Presenter: Sherrie Ebyam

 Long-Term Financial Plan is being done by the County and Member Ebyam would like to be involved in the creation of the plan.

Committee Action: Upon motion, by Member Allman, seconded by Member Antle it is ORDERED to have a discussion with Member Antle to request four hours of the appropriate persons time for consulting with the development of a long-term financial plan using their expertise within the next three months.
