NOTICE OF NON-CULTIVATION

Pursuant to Section 10A.17.080 (B)(6)

If a permit is granted pursuant to this paragraph (B) any future revocation or lapse in renewal of such Permit shall extinguish the ability of any person to obtain a Permit for such cultivation site, unless otherwise allowed by this Chapter 10A.17; provided, however that not more than once in a five year period, a Permittee may file with the Cannabis Department, on a form prescribed by the Department, a Notice of Non-Cultivation instead of an application to renew the Permit, and the Permittee's ability to obtain a Permit for such cultivation site will not be extinguished.

Pursuant to Section 6.32.050 (B)(1)(d)

Persons who file a Notice of Non-Cultivation with the Cannabis Department pursuant to Chapter 10A.17 shall not be required to pay the minimum payment amounts required by this paragraph B.1 for either (1) the calendar year in which the Notice of Non-Cultivation is filed or (2) the calendar year in which the Notice of non-Cultivation terminates, at the election of the Person, which election shall be made at the time of the filing of the Notice of Non-Cultivation; for Persons who do not make an election, the Treasurer-Tax Collector shall select the first of the two calendar years.

In filing this Notice of Non-Cultivation, I hereby acknowledge and declare the following:

1. I am the Permittee or authorized representative of the Permitted entity.
2. I am filing this Notice of non-Cultivation pursuant to Section 10A.17.080 (B)(6) and Section 6.32.050 (B)(1)(d).
3. As of the date stated above, I have ceased all cannabis cultivation activities at the cultivation site in excess of the limitations of paragraph (B) or (C) of Section 10A.17.030 (personal/medical/caregiver exemptions).
4. For the one-year period after filing this Notice of Non-Cultivation, I am prohibited from cultivating cannabis in excess of the limitations of paragraph (B) or (C) of Section 10A.17.030 (personal/medical/caregiver exemptions).
5. After filing this Notice of Non-Cultivation, the County will inform the State of California that I do not have local authorization to cultivate cannabis for the 1-year Non-Cultivation period.

6. Violation of the prohibition on cultivating beyond the personal cultivation exemptions shall be a violation of County Code, subject to administrative citation and penalties, and may be followed by nuisance abatement procedures
7. I hereby consent to inspection by Mendocino County of my cultivation site to determine compliance with the terms on this Notice and Chapter 10A.17 at any time and without any notice.
8. I may only file a Notice of Non-Cultivation once during a five year period.

I declare under penalty of perjury, under the laws of the State of California, that the information provided herein is true and correct and that I agree to act in accordance with the statements herein.
