BALLOTS LEFT TO BE COUNTED MARCH 5, 2024 PRESIDENTIAL PRIMARY ELECTION

Mendocino County Assessor-County Clerk-Recorder Katrina Bartolomie announced that as with every other election, there are ballots left to be processed (unprocessed ballots) as part of the official canvass. Mendocino County has 14,665 Vote By Mail ballots to process and 593 Conditional Provisional/Provisional ballots to review and process.

Of the outstanding ballots left to count in the "Hot" contests are:

1st Supervisor District race has 3,155; 2nd Supervisor District race has 2,414 and

4th Supervisor District race has 3,194

The deadline for elections officials to receive vote-by-mail ballots returned by mail for the March 5, 2024, Presidential Primary Elections is March 12, 2024, if it is **POSTMARKED on or before Election Day** and delivered to the election's office by the US Postal Service or a private mail delivery company not later than seven (7) days after Election Day. We will update our results by 4pm March 12, 2024.

Our Election Night Final Report showed results of 324 Poll Ballots and 7,094 Vote By Mail ballots.

Mendocino County's Unprocessed Ballot Report has 14,665 Vote By Mail ballots received on or before Election Day and 582 Provisional Ballots, 11 Conditional Voter Registration ballots to review and process for a total of 15,258 ballots. Included in the total number are 135 Vote-by-Mail ballots that require further review for various reasons. All Poll Ballots were tabulated and reported in our Election Night Final Report.

Per State law, we have 30 days to complete the canvass. The Statement of Vote, which breaks down Final Official Results by precinct, will be available at that time.
