OWNER/APPLICANT/AGENT: Sundial Ranch LLC

REQUEST: Administrative Permit to install an agricultural processor's craft operation to produce brandy by leveraging grapes produced on an adjacent property, which has common ownership. Whisky is also proposed to be manufactured. The applicant plans to use an existing building to install the necessary distillery equipment, there will be no secondary improvements such as wells, grading, vegetation removal or new roads.

ENVIRONMENTAL DETERMINATION: Categorically Exempt

LOCATION: 1.59± miles northwest of Hopland, lying on the north side of Hewlitt and Sturtevant Road (private), 1.14± miles northwest of its intersection with Highway 101, located at 11700 Hewlitt and Sturtevant Road, Hopland; APN: 048-080-04.

The appeal will be placed on the next available Board agenda and the appellant will be notified of the time and date. Appeals to the Board do not guarantee that the Zoning Administrator's decision will be overturned. In some cases, the Board may not have the legal authority to overturn the decision.
