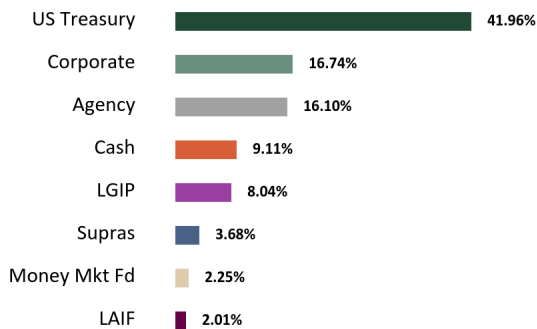

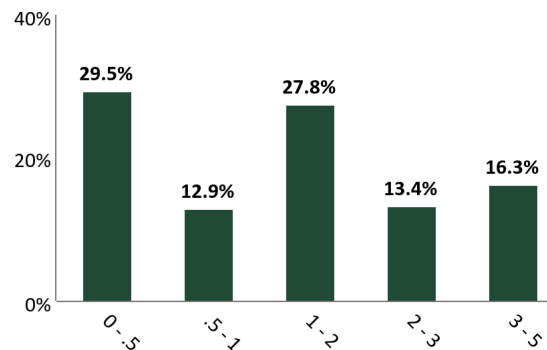

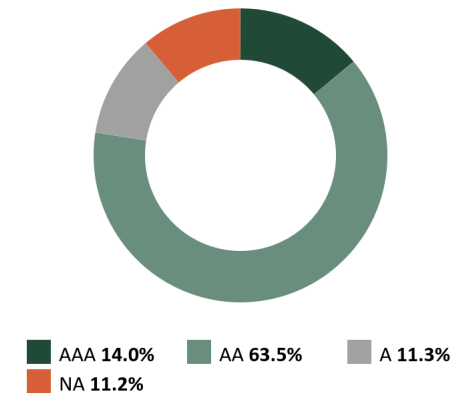
Sector Allocation
