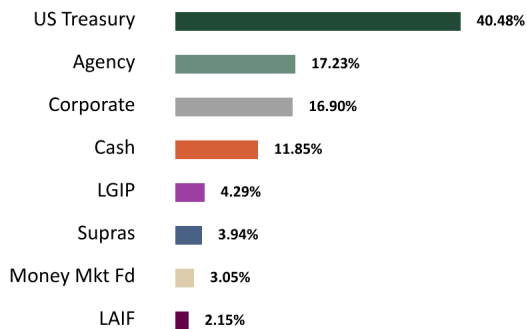

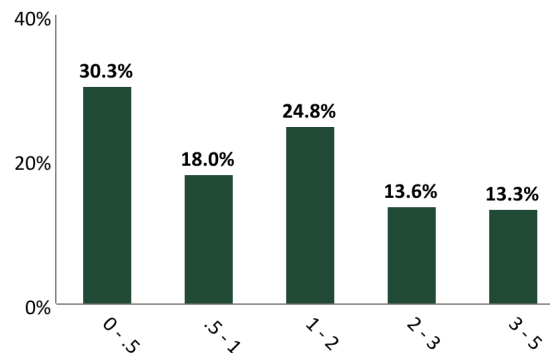

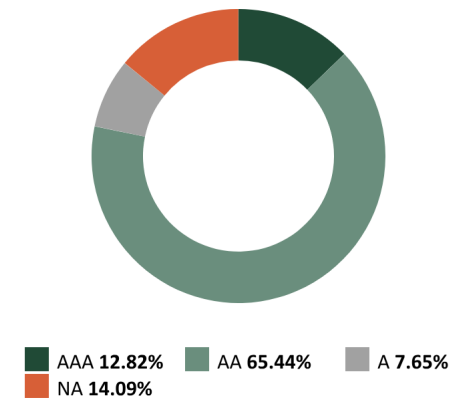
Sector Allocation
